

**PEBBLE CREEK CONDOMINIUM TRAILER, BOAT, MOTORHOME AGREEMENT 2022**

Agreement entered into this \_\_\_\_ day of \_\_\_\_\_ 20\_\_\_\_, by and between **PEBBLE CREEK CONDOMINIUM** (herein after referred to as **PEBBLE CREEK**) and \_\_\_\_\_ (herein after referred to as **USER**) who resides at PEBBLE CREEK Condo unit # \_\_\_\_\_ and has a daytime phone number of \_\_\_\_\_. PEBBLE CREEK has a limited number of Parking Spaces for Trailers, Boats and Motorhomes, which are common elements of the Pebble Creek Condominiums at 3550 S. Harlan St., Denver, CO 80235. The USER is desirous of using such Parking Space for the storage of a trailer, boat, or motorhome, which PEBBLE CREEK agrees to allow USER to do so pursuant to this agreement. Now, therefore, in consideration of mutual promises, covenants, and conditions contained herein, and other good and valuable consideration, the receipt of which is hereby acknowledged, it is agreed as follows:

1. PEBBLE CREEK shall provide use of and access to Parking Space # \_\_\_\_\_ to the USER on January 1<sup>st</sup> 2022 through December 31<sup>st</sup>, 2022. Continuation of Parking Space occupancy by USER is by NEW AGREEMENT AND PAYMENT OF FEES annually.

2. USER shall pay, with the acceptance by PEBBLE CREEK of the Agreement as follows:

A. Parking Space fee of \$100.00 annually.

B. This Agreement must be executed along with payment, for access and use of the Parking Space

C. The Parking Space Fee will be prorated to \$50.00 if the agreement is entered into on or after September 1, 2022 through December 31<sup>st</sup>, 2022. No refunds shall be made for any reason.

3. **Termination of Parking Space Agreement:**

A. This Agreement automatically terminates on January 31<sup>st</sup>, 2023.

a. USER must remove all vehicles on or before January 31<sup>st</sup> 2023, if a new agreement/payment is not made.

i. Vehicles remaining five days after the Agreement terminates shall be removed without further notice to the USER.

B. This Agreement may be terminated by PEBBLE CREEK for violation of Parking Space Rules by the USER. In the event of early termination of this Agreement, USER shall remove all vehicles stored within five days after the Agreement terminates shall be disposed of without further notice to the USER. **USER INITIALS** \_\_\_\_\_

6. **Parking Space Rules:**

A. Vehicles must have a current license and insurance. **USERS INITIALS** \_\_\_\_\_

B. Storage of any Flammable Material IS STRICTLY PROHIBITED. This includes, but is not limited to paint, propane, gasoline, and charcoal. **USER INITIALS** \_\_\_\_\_

C. Storage of any Hazardous Material IS STRICTLY PROHIBITED. **USERS INITIALS** \_\_\_\_\_

D. USER agrees to keep common area in the vehicle clean.

E. Failure to abide by any of the above shall result in termination of this Agreement.

7. USER agrees to indemnify and hold harmless PEBBLE CREEK from any and all claims, loses, or damages to any stored vehicles or any personal injury, which may be suffered by USER by other persons use of the Parking Space or from any damage to or loss of stored vehicles due to damage from other USERS.

8. USER for himself, agrees to indemnify and hereby releases and discharges PEBBLE CREEK from any and all claims, loses, or damages suffered while on the grounds of PEBBLE CREEK or which my otherwise arise out of the USER'S use of the Parking Space. **USER'S INITIALS** \_\_\_\_\_

9. USER agrees to indemnify and hold harmless PEBBLE CREEK from any claims arising from a direct result of USER'S actions or trailer, boat, or Motorhome stored.

10. USER agrees to pay or otherwise reimburse any other **USER** for damage incurred as a direct result of USER actions or vehicles stored.

11. Should USER fail to pay any amount called for in this agreement or otherwise violates the terms of this Agreement, USER shall reimburse PEBBLE CREEK for all reasonable attorney's fees incurred as a result of such violation.
